NOTES OF INTEREST

Mr. Samuel Levi Sadler, composer of Langston University's Alma Mater--"Dear Langston"--died August 26, 1967, in Muskogee, Oklahoma. Mr. Sadler was also a former Professor of English and a member of the University's graduating class of 1910.

A grant of \$4,050 has been received under the State Technical Services Act to help underwrite cost of evening courses in data processing for small business personnel during 1967-68. The grant must be matched by \$4,050 (Total--\$8,100) from other sources.
